Pathology Review: Gynecologic, Genitourinary and Gastrointestinal Pathology for the General Pathologist

About the Meeting

This seminar is designed to provide a practical review of gynecologic, gastrointestinal and genitourinary pathology. Faculty will discuss basic to advanced techniques, pitfalls and pearls to pathology diagnosis. To enhance your learning opportunities with the 2013 meeting, we will be offering a Pathology Self Assessment Module (SAM) during the program. Rounding out the curriculum, for the third year, are interactive case reviews of gynecologic, obstetric, gastrointestinal and genitourinary pathology emphasizing the material presented at the beginning of the day.

Target Audience

- More accurately diagnose pathologic disorders in gynecologic and obstetric pathology.

- Recognize, assess and diagnose gastric polyps, dysplasia and their clinical correlations.
- Differentiate neoplastic and non-neoplastic small intestinal pathology.
- Recognize mimickers of bladder carcinoma and increase understanding of the diagnosis and staging of bladder carcinoma.
- Develop a better understanding of Gleason-Gleason grading system.
- More accurately recognize, evaluate gastrointestinal mesenchymal lesions.
- Recognize mimickers and variants of prostate carcinoma.
- Increase understanding of spindle cell lesions in the genitourinary tract.

No special educational preparation is required for this CME activity.

Needs Assessment

This is an annual meeting aimed at pathologists to improve the quality of their diagnostic and consulting skills. The topics are selected through identification of professional practice gaps, the review of previous evaluations, expert faculty opinion and input from participants.
